WAIT LIST PRIORITY PLACEMENT POLICY

Placement on the wait list is based on a priority system where siblings of currently enrolled students are given the highest priority ranking (#1), and the priority for the other categories is as noted above (#2 to #10). Therefore, any family with a higher priority ranking will always be placed ahead of any family with a lower priority ranking regardless of when a family is placed on the wait list. The priority rankings always take precedence above the time at which a family is placed on the wait list. Any questions should be clarified with the contacts listed below prior to signing this form.
